The Gaslighting of America: The COVID Pandemic and Ozone Therapy

Gaslighting is a form of psychological manipulation in which the abuser attempts to sow self-doubt and confusion in their victim's mind. Typically, gaslighters are seeking to gain power and control over the other person, by distorting reality and forcing them to question their own judgment and intuition.

For example: $7 \times 9 = 41$

For example: "Ozone is a toxic gas with no medical application." (FDA Federal Regulation Title 21)²

Ultimately, gaslighting comes down to psychology—the ability or inability for one person to change the mind of another. One way or another, we witness a similar kind of thing daily in attempting to discern the difference between

information and disinformation. Facts become blurred and reality is often distorted. For instance, politically the term "alternative facts" came into vogue just a few years ago. This, of course, is absurd. In many cases there is only one objective truth. The Earth is not flat, it is round; we really did land a man on the Moon in 1969; vaccines have played an important role in helping humanity overcome such diseases as smallpox and polio. *Facts matter*.

In math, $7 \times 9 = 63$. That's a fact. No matter who says it equals 41, it really equals 63. However, if a person in a position of power keeps insisting the answer is 41, this would be an instance of gaslighting.

Consider Vladimir Putin's decision to invade Ukraine. We've seen how his propaganda has infected the Russian people as he bombs hospitals, yet we have also seen thousands of young Russian men flee their country because they see through the propaganda.

In the U.S., disinformation has played a significant role in increasing the number of people who have died from COVID because many have bought into conspiracy theories, and thus refused to get vaccinated. According to *Scientific American*, for the month of March 2022, unvaccinated individuals had a COVID death rate 17 times greater than those who had been vaccinated.

Since we are talking about deaths, consider the recent earthquake in Turkey and Syria and then compare that number to the number of COVID deaths on a daily basis for the last three years. Where something on the order of 50,000 Turks and Syrians have died during that tragic event, we have lost an average of 35,000-50,000 per month during the winter months of this COVID pandemic.⁴

Or we could look at another horrible tragedy, the terrorist attack on 9-11. Approximately 3,000 people died in the collapse of the Twin Towers in a single day. September 11 (9-11) is one of those flashbulb moments where everyone who was on the planet at that time knew precisely where they were when it occurred. Well, we have been losing the equivalent of a 9-11 terrorist attack every two or three days from COVID for the last three years!


This article will make the case that the reason the COVID pandemic lasted so long and killed so many people was due

in part to gaslighting. For instance, much misinformation was spread and COVID treatments (like ozone therapy) were not pursued that could have saved many lives. What I find most troubling is not just the outright disinformation promulgated by the FDA's Federal Regulation Title 21, which has no basis whatever in reality, but the simple fact that governmental officials, experts in immunology and leading journalists in print and the TV mass media could be so easily duped or ignore information presented to them. Either ozone is a toxic gas with no medical application or not. It is as simple as that!

With regards to vaccines, which are clearly necessary, what the media and the mainstream scientists do not tell you is how vaccines actually work. Vaccines, of course, don't kill anything. It is our antibodies that do the killing. If you peruse the thousands of articles written over the last three years on the COVID virus, you would

be hard-pressed to locate a single report that explains precisely how the antibodies achieve this. I have just edited and published a new book, *Ozone Therapy for the Treatment of Viruses: The Science and the Promise of Healing with Ozone* (Healing Arts Press, 2023), which delves into this issue. 

THE IMMUNE SYSTEM — Marc J. Seifer, Ph.D.

All life forms have learned to survive in a hostile environment. That is what the immune system is all about. It is a complex set of defenses that evolved over hundreds of millions of years to protect a species from invading pathogens such as microbes, parasites, bacteria and viruses. One of our most important defenders is our macrophages. MACRO = large, and PHAGE = eat. Macrophages are large eaters manufactured in our bone marrow. As part of the white blood cell system, their task is to seek out various pathogens, surround, engulf and literally eat them, thereby destroying them. According to various immunologists, macrophages evolved from amoeba hundreds of millions of years ago. In other words, we are a composite being comprising a number of separate life forms that for all intents and purposes are autonomous. Macrophages are mobile, they swim inside us and they have tentacles of sorts which can literally reach out and grab bacteria or viruses and bring them close so they can be engulfed and thereby destroyed.



The immune system consists of highly complicated interconnected self-directed defense structures whose entire goal is to protect us from a whole host of various invaders. Through chance mutation and survival of the fittest, the immune system has evolved to protect us for the duration of our lives. The product of Mother Nature, this intricate network of its myriad components act and interact in ingenious ways.

The immune system has several lines of defense, starting with the skin, which comprises an area covering about two square meters. The mucous membranes, on the other hand, which comprise the digestive, respiratory and reproductive tract, covers about 400 square meters, equivalent to about "the size of a tennis court." Thus the skin and mucous membranes comprise the first line of defense. The second line of defense is called the "innate system." To give you an idea of how incredibly complex this subject is, the textbook *Basic Immunology*² has over 500 terms in its glossary. Besides the macrophages, cells of the immune system include: lymphocytes, some of which can attack living cells that are still infected; mast cells "which help to recruit other leukocytes to destroy microbes"; neutrophils, which are produced by macrophages, and protect us from infection, some of which produce hydrogen peroxide and different forms of ozone to help disinfect incoming pathogens; phagocytes that remove dead cells; opsonins which tag antigens [invaders] for destruction; and lysosomes, which have destructive enzymes that break down and destroy bacteria and viruses.

The immunologist Lauren Sompayrac¹ points out that merely stepping on a splinter would quickly lead to death if not for the immune system, as bacteria on the splinter would reproduce at such a rapid rate if the various cells listed above did not come to the rescue.

Another author, E.J. DuPraw,³ notes that "viruses are parasites that must remain inactive until they are able to enter a living cell. Thereafter, they can direct the cell's own energy mechanism for the production of a new virus particle." DuPraw also informs us that the word "virus" literally means "poison," thus viruses, by definition, are antigens, and these in turn stimulate the development of white blood cells or antibodies that are able to react specifically with the inducing microorganism. At this point macrophages come into play. Over time, they learn to recognize the antigen so that they can engulf and eat the pathogen, destroying it with an arsenal of destructive enzymes.

Curiously, the mainstream textbooks on the immune system for the most part spend no time whatsoever discussing the actual chemistry of this arsenal, describing them simply as enzymes with destructive capabilities. As an example, look at all the publicity, money, time and energy that has gone into the creation of vaccines to defeat the COVID-19 virus. Yet any substantive discussion of how the antibodies created from the vaccine actually destroys the COVID virus is not at all discussed.

In order to fully understand how the immune system works, we need to understand how antibodies actually destroy viruses. What is the chemistry involved? Mainstream textbooks note that lysosome killer cells contain powerful chemicals and enzymes used to destroy the pathogens, but they do not explain what happens next. For instance, if one goes to their indexes the words "hydrogen peroxide" and "ozone" do not appear in these highly complex texts.

We know that stem cells in the bone marrow can become white or red blood cells. Where the white blood cells comprise the cells of the immune system, the red blood cells capture oxygen from the lungs and "transport and deliver" O₂ to all parts of the body.

Where white blood cells are produced at a rate of about 100,000 per second, red blood cells are produced at an even more fantastic rate of two million per second! Where the B-cells mature in the bone marrow, the T-cells transform near the heart in the thymus gland.

However, we now know that if an infection takes place, the immune system will manufacture hydrogen peroxide which, in and of itself, will help disinfect the wound. But the processes involved in manufacturing this product is more complicated. While H_2O_2 , travels to the site of infection, it simultaneously alerts another division of the immune system to send in macrophages, some of which are scavenger cells whose job it is to digest the dead cells so that they can be removed from the body; and it may also alert the red blood cells which come to the site to provide oxygen to help in the healing process.

In the article "Hydrogen Peroxide Marshals Immune System," from Harvard University Medical School, author David Cameron discusses a study conducted on zebra fish. When the tail of a fish was purposefully injured, one group of white blood cells manufactured hydrogen peroxide, H₂O₂, at the wound site for a twofold purpose: (1) Disinfecting the wound and (2) Sending out a signal which causes additional white blood cells with other functions to "gather at the wound." This research, conducted by Timothy Mitchison and Hasib Sabbagh from Harvard and Thomas Look from Dana-Farber Cancer Institute, also uncovered a specific gene responsible for this essential immune defense system response. In zebra fish missing this gene, hydrogen peroxide did not appear at the wound site, and additional white blood cells were not summoned to the wound site.

Recent studies have suggested that antibodies can also catalyze different forms of O₃ or ozone. This enzyme could be called a natural killer cell which destroy bacteria, parasites and viruses and other infected cells, including some cancer cells.

In 2001, chemist Paul Wentworth from Scripps Institute covered similar ground when he discovered that antibodies, also known as immunoglobulins, destroy bacteria and viruses by apparently producing the reactive gas ozone. "The ozone," Wentworth's associate, Richard Lerner, MD, explains, "may be part of a previously unrecognized killing machine that would enhance the defensive role of antibodies by allowing them to subject pathogens to hydrogen peroxide and participate in their killing." Further studies by Yamashita *et al.*, as reported by the National Academy of Sciences and partially funded by the Mitsubishi Pharma

Further studies by Yamashita *et al.*,6 as reported by the National Academy of Sciences and partially funded by the Mitsubishi Pharma Foundation, found that neutrophils, as "one of the professional phagocytes," are on the first line of defense during an infection, and they kill invading bacteria, viruses and microbes by producing "an oxidant with the chemical signature of ozone." Supporting the findings of Wentworth and colleagues that antibodies can catalyze ozone generation in neutrophils, their results suggest that due to this research "ozone therapy should be beneficial in helping fight infectious diseases."

Paul Wentworth from Scripps Institute, who discovered 20 years ago that our own antibodies manufacture ozone for the express purpose of disabling all sorts of incoming pathogens. A powerful disinfectant, Olympic teams often use ozone generators to disinfect their swimming pools. The difference between O_2 (oxygen) and O_3 (ozone) is that this more unstable form of oxygen is an enemy to bacteria, microbes and viruses because O₃ has the ability to "disrupt viral proteins, lipid proteins, lipids and glycolipids in the actual virus. As a result, ozone creates a dysfunctional virus, which cannot replicate." This statement was made by Dr. Peter Papadakos, Director of Clinical Care Medicine, Professor of Neurosurgery at the University of Rochester.⁵ When you consider that the immune system is the product of literally hundreds of millions of years of evolution, chance mutation and survival of the fittest, is it really such a stretch to realize that Mother Nature has learned how to convert O_2 , which we breathe in, into O_3 when O_3 (ozone) is known to boost immune system functions?

In 1984, I attended and spoke at the Tesla Centennial Conference held in Colorado Springs. Two years away from completing my doctorate—which was a psychohistory on why Tesla's name disappeared from the history books—my talk was focused on why the great wireless plans Tesla began in 1901 did not succeed. A key reason boiled down to the simple fact that Tesla ran out of capital and he was unable to convince his backer, financier J. Pierpont Morgan, to provide the additional funds necessary to complete the project.

At this 1984 conference, medical doctor George Freibott gave a lecture on something I had never heard of before, ozone therapy. Dr. Freibott told a story about one of his patients dying of cancer, his body riddled with tumors. As a last resort, Dr. Freibott gave the patient ozone therapy, which consisted of injecting into his bloodstream a combination of about 97% pure oxygen and 3% ozone, and according to the doctor, this treatment worked, the tumors were "shed" and the patient was healed.

I came from the world of parapsychology and so I often encountered numerous far-out possibilities—UFOs, mental telepathy, psychokinesis, astral projection and so on. Thus, I thought this account was just another far-out story that one encounters when one travels in such circles.

While completing the biography *Wizard: The Life & Times of Nikola Tesla* (1996), I remembered the Dr. Freibott story. I knew the reason the good doctor was at the conference was because Tesla invented and patented an ozone generator in 1896 and that he sold ozone generators to medical personnel throughout the early part of the 20th century. So I did a bit of research and found confirmation of the information Dr. Freibott presented in his talk by discovering the 1980 *Science* article "Ozone Selectively Inhibits Growth of Human Cancer Cells." I included the Freibott story in *Wizard*, along with the *Science* article as an endnote. That was over 25 years ago, and in all that time, not a single person has ever men-

tioned that one-page story to me, so I hadn't really thought about Freibott's presentation again.

In January 2020, COVID was beginning to spread. I thought back to George Freibott, Googled his name and out popped the 1995 book *The Story of Ozone*, written by a dozen medical doctors (including Deepak Chopra) and edited by Saul Pressmen.⁷ In a web version of *The Story of Ozone*, I read the following:

Ozone has been found to be an extremely safe medical therapy, free from side effects. In a 1980 study done by the German Medical Society for Ozone Therapy, 644 therapists were polled regarding their 384,775 patients, comprising a total of 5,579,238 ozone treatments administered. There were only 40 cases of side effects noted out of this number which represents the incredibly low rate of .000007%, and only four fatalities. Ozone has thus proven to be the safest medical therapy ever devised.

The book has articles on superoxygenation for health, the cause and prevention of cancer, free radicals, ozone and antioxidants, etc. I found myself thinking, "I'm onto something."

My next step was to locate ozone therapists and to my pleasant surprise I came upon Dr. Howard Robins from New York City. I happen to have been born and raised in New York and as it turns out, we are the same age. He could not have been nicer and he put me in touch with Dr. Robert Rowen in California. They told me that in 2014 they decided to risk their lives to fly out to an Ebola hot zone in West Africa with an invitation from the president of Sierra Leone to teach medical personnel there ozone therapy as a way to kill the Ebola virus.

Remember how paranoid we all were when COVID first began? I remember using plastic gloves to fill up my gas tank because I didn't want to get the virus from touching the handle! We wore the masks, people in old age homes were dying en masse, it was impossible to find any toilet paper, the entire country was shut down.

COVID has perhaps a 2% death rate. Ebola has a 60% death rate. That means it is 30 times more deadly! Who in their right mind would fly into an Ebola hot zone to work with people potentially dying of Ebola? Well, Dr. Robert Rowen and Dr. Howard Robins did. So what does that tell me? It tells me that they either both have a screw loose or they knew what they were doing. Ozone therapy kills viruses. That is what they knew.

I then contacted Dr. Howard Liebowitz in Los Angeles. Turns out he was curing COVID patients until the FDA (via the FTC) came down on him, forcing him to stop advertising that he could cure this dreaded disease. Sandbagged, here was a clear instance of a medical doctor doing good work who got gas-lit by the Federal government!

In April 2020, when we were at the very beginning of this pandemic, with about 25,000 deaths throughout the country, Dr. Robins sent me an article written by Rhian King from *The Ibizan*.⁸ In it, Dr. Alberto Hernandez states that at Spain's Nuestra Senora del Rosario Polyclinica, "Many patients who were about to be intubated and connected to mechanical ventilation have, thanks to ozone therapy, not only avoided it but improved to the point of not requiring oxygen with just a few treatment sessions." He called the results "spectacular." In comparison, by this time thousands of COVID patients were dying on ventilators.

If ozone therapy is really that powerful, then I think that I'm sitting on the greatest story of our time, a bang-out successful treatment for COVID, an immediate solution six to eight months before the vaccines would be available! Both Dr. Robins and Dr. Rowen confirm this by telling me that they too are successfully disabling the virus in their COVID patients, and they are explaining scientifically why ozone therapy disables viruses, publishing their results in the peer-reviewed *Journal of Infectious Diseases and Epidemiology*.9

Within the next few months, Dr. Hernandez completed his clinical trial. He takes 18 Covid patients and splits the two groups randomly in half. The nine in the treatment group who get ozone therapy were out of the hospital an average of seven days as compared to 28 days for the control group. I then locate another clinical study performed by Dr. David Brownstein. Written when people were dying of COVID in droves, he takes 37 COVID patients and treats them with megavitamins, hydrogen peroxide nebulizer and ozone therapy and all 37 are cured. 10,11

So I had solid supporting evidence and that prompted me to undertake a letter-writing campaign to tell the powers that be that we've got a way to end this horror quickly so we don't have to sit by for another six months watching another few hundred thousand people die as we wait for the vaccines to roll out. I write to Anderson Cooper and a dozen comparable TV news talking heads. I call and write "60 Minutes" and "Frontline." I send my information to *New York Times, LA Times, Washington Post, TIME, Boston Globe* and the *Providence Journal*. I also write to: 50 senators and congressmen; the presidents of 20 top universities whose campuses are ghost towns during the pandemic; a dozen or more governors; President Trump and VP Pence; and Dr. Fauci, Dr. Birx, Dr. Jha and others.

Football and baseball stadiums were empty. Over 50,000 fans missing. That's a lot of lost revenue! I therefore sit down and write a letter to every owner of every football and baseball team and also to selected coaches and lead players and tell them that if they get an ozone therapist—and I'm talking about a medical doctor—to treat any athlete who comes down with COVID, the evidence supports the conclusion that the player will be healed. I do the same thing with the cruise lines, writing to the top three. An ozone therapist aboard a cruise ship would solve everything for them. And this was when people were dying on board and entire ships were being quarantined.

The results of this information campaign? Out of the hundreds of letters that I sent with solid proof of the efficacy of ozone therapy, I received not a single substantive response, although I did receive the following:

(1) A nice letter from the CEO of the Green Bay Packers.

- (2) Non-committal vague letters from one senator, Tammy Baldwin, and the governor of Hawaii.
- (3) Eight months later I receive a letter from my Congressman, James Langevin, which lets me know he actually considered what I wrote. Langevin mentions some of the positives of ozone therapy but then veers into taking the FDA bait, the party line that ozone is toxic and has no medical application. Here I see that Langevin has been classically gas-lit. His perception of reality has been distorted and by citing both the positives and negatives of the topic, unable to ascertain which is true and which is total malarkey, he sides with the words of the FDA and comes to the wrong conclusion.

What astounded me more than anything was the complete lack of interest of any news reporter, given that most networks were covering the COVID pandemic 24-7. Woodward and Bernstein, where are you? I did not hear from Dr. Fauci, Dr. Birx or Dr. Jha, even though I wrote to them multiple times and included all the science that is embedded within this essay.

One of the key problems pointed out to me by a pharmacist who read an earlier version of this paper was that there is indeed a good amount of evidence of the dangers of using ozone. According to his findings, "Ozone tested topically in WWII for war wounds: 15 minutes damaged both bacteria and human tissue...Ozone has a toxicity...to human immune cells, living tissue and cardiac systems...so the safety and effectiveness would have to be shown in numerous clinical trials, animals first, human trials later if possible—if ever to reach licensure."

Several points about these criticisms need to be addressed. There have been numerous clinical trials for a variety of viral diseases over the last 50 years administering ozone therapy, two of which referred to above specifically tested its effectiveness against COVID. Once one understands the simple fact that such viruses as Ebola, SARS, MERS and COVID all share the same vulnerability—a lipid envelope (outer skin) that is vulnerable to being disabled by ozone therapy—there really is no point in first demonstrating its effectiveness with animal studies. It has already been done. This is a wellknown medical procedure that literally has over 50 years research and published findings all coming to the same conclusion—that ozone therapy kills all kinds of viruses. Plus, in the case of pandemics, time is of the essence. It would be one thing if this was some bizarre new chemical that someone discovered. But that is not the case. One doesn't need to test penicillin every time it is used for treatment. Ozone therapy kills viruses and when administered by medical professionals has proven to be safe. How do we know this? Because there are hundreds of medical doctors going back well over 50 years who have used this treatment tens of thousands and in some cases hundreds of thousands of times with numerous positive results.

The studies that warn of the toxic aspects of the use of ozone reminds me of fire. The misuse of fire has caused an average of 350,000 houses to be damaged or burned down every year and over 2,500 deaths per year. Should we then eliminate the use of fire? I know that sounds ridiculous, but it is no more ridiculous to the hundreds of medical doctors throughout the world who are successfully using ozone therapy through the decades who daily treat a whole host of



pathogens to ask them to no longer announce publicly what they well know. The key here, and why it is analogous to fire, is the *amount* of ozone used in treatment. Ozone therapy is actually a misnomer. It is really *oxygen-ozone therapy*, 97% of which is pure oxygen and only a very small percentage (3%) is ozone. Every medical doctor who uses ozone therapy is well aware of the dangers of ozone. That is why they only use a very small amount when injecting this combination of pure oxygen and ozone into a patient's bloodstream. They never inject just ozone into a bloodstream because that would be toxic and highly dangerous.

After hitting so many dead ends, seeing no other choice, I decided to put a book together. Receiving permission from a number of authors, including four medical doctors, to include their articles on the efficacy of ozone therapy, I was fortunate enough to have gotten a positive response from Inner Traditions, a publishing house where I have two other books, and I found to my delight that the book will come out through their Healing Arts division and it will be distributed by Simon & Schuster.

Ozone Therapy for the Treatment of Viruses explains precisely how and why the FDA and FTC have blocked the use of ozone therapy. Because of their myopic draconian position, a strong case can be made that the real cause of the extent of this pandemic has more to do with the blackballing of a medical procedure known to disable viruses than to just the virus itself. A rapid effective way to disable this virus was available from the start, but the FTC sent out WARNING LETTERS in capital boldfaced letters to every ozone therapist they could locate (an estimated 350), to "cease and desist" advertising that they could disable the virus, their reason being FDA Federal Regulation Title 21 which gaslights not only ozone therapists through direct threats, but more subversively to the rest of the medical community, governmental officials and, most sadly, to newspaper journalists and TV news talking heads who should not have been so easily taken in.

Clearly, the most likely reason why none of the major news outlets reported the clinical trials performed by Dr. Alberto Hernandez or Dr. David Brownstein, was because they listened to their lawyers, who feared retribution from the Federal Government. 
